### TX | SPRY - Seaport and Rail Yard Areas Emissions Reduction Program

#### ABOUT

An estimated \$20 million in grants are available to upgrade or replace older drayage trucks and container handling equipment operating at eligible seaports and rail yards.



#### FUNDING/APPLICATION TIMELINE

Grant applications accepted on a first-come, first-served basis beginning on April 18, 2024.

Applications will be accepted until March 4, 2025.

#### ELIGIBLE AREAS

Seaports or rail yards must be in an [eligible county](#).

Equipment must operate in nonattainment areas or affected counties. Please refer to the [Eligible Counties for Usage](#) list.

#### GRANTS

For replacement projects, grant recipients may be eligible for reimbursement up to 80% of the eligible costs with the purchase or lease of the replacement equipment, not to exceed the maximum grant amount listed in the Maximum Eligible Grant Amount Tables below.

#### PROGRAM REQUIREMENTS

Old vehicles must have operated in eligible seaports or rail yards for at least 200 days per year for the preceding two years.

New vehicles must operate 200 days per year in eligible seaports or rail yards for the duration of the project (5 years). In addition, 50% or 80% of the annual and total use must occur in nonattainment areas and affected counties.

#### THIRD-PARTY APPLICATIONS
